## ALBION HOUSING COMMISSSION SMOKE FREE PROPERTY POLICY

## Resolution 015-016-005

Adopted: 03-15-16 Revised: 05-16-17

Effective April 1, 2016, smoking is prohibited in all property owned and operated by the Albion Housing Commission ("AHC"). The smoking ban is intended to improve the quality of air and the safety of residents and employees. Implementation of a Smoke Fee Policy is mandated by the U.S. Department of Housing and Urban Development and it is consistent with their program goals and objectives. There are No exceptions to this policy. Smoking is only permitted in specifically designated areas (city sidewalks).

- Tenants may not use, smoke, hold or carry lighted tobacco in any form, including
  cigarettes, e-cigarettes, pipes, waterpipes, cigars, etc while in AHC owned property.
  Effective April 1, 2016, all current residents, all employees, all guests and all new
  residents will be prohibited from smoking anywhere inside of any AHC owned or
  operated property, including but not limited to rental units, vehicles, lobbies, restrooms,
  hallways, reception areas and any common areas (community room, laundry rooms,
  etc).
- 2. Smoking outside of AHC owned buildings shall be permitted only in designated smoking areas, which shall be at lease 25 feet from a door, walkway, window or ventilation system. In addition, smoking areas shall be located sufficient distances from the buildings and sideways so that secondhand tobacco smoke does not enter the buildings and to ensure residents and guests can avoid walking through secondhand tobacco smoke to enter or lease AHC owned properties.
- 3. Persons who smoke in designated smoking areas (city sidewalks) are responsible for properly disposing of cigarette butts or tobacco products so as not to litter the grounds.
- 4. Employees and residents who smell tobacco smoke and/or see cigarette butts, yellow walls (due to smoke), etc from inside AHC owned buildings are to report this to the office as soon as possible. AHC's management staff will identify the source of the smoke and take appropriate action when deemed necessary.
- 5. Existing Residents will receive a copy of this Smoke Free Policy and are required to sign lease modifications reflective of the Smoke Free Policy before April 1, 2016. New residents who sign leases affective after April 1, 2016 will be given copies of the Smoke Free Policy and their lease will reflect this policy.
- 6. AHC will post signage to clearly designate smoking and non-smoking areas.

AHC staff is responsible for fully implementing this policy, which includes taking steps to insure 100% of the existing residents, and employees are aware of and abide by the policy. Failure to abide by this Smoke Free Policy is considered a lease violation. Employees are covered by the Smoke Free Work Place Policy Adopted December 12, 2007, Resolution 07-08-004.
